## 2. Police Matters

PC Williamson reported that there had been an attempted burglary in Castle Upon Alun and an incident of dangerous driving in St Brides Major/ Southerndown. There were two reports of Anti Social Behaviour, one in St Brides and one in Ogmore by Sea where a small fire had been lit in the car park. A car had been driven over the cliff in Southerndown. An incident of reckless driving in Heol y Mynydd had been reported by a member of the public via Operation Snap, the driver has been sent a warning letter.

## **8.4 Councillors Allowances and Expenses**

Members must inform the Chair/Clerk in writing if they do not wish to receive this annual allowance. The council is not, as a body, able to opt out. A statement of allowances paid must be published by September every year. This is required in order to be compliant with Welsh Government regulations. **Action:** Members must provide the Chair with payment details or decline the payment in writing by the end of April.
- **8.4.2** In order to comply with Welsh Government Regulations it was **Resolved** that "This Council will reimburse Members for the cost of office consumables upon the presentation of valid receipts."

## 9. Rivermouth Car Park.
