# St Brides Major Community Council Minutes of the meeting held on Monday 12<sup>th</sup> May 2025 at All Saints Church, Southerndown.

# 1. Welcome and Apologies

#### 2. Declarations of Interest

Cllr Morgan made the Council aware of his position on the Ogmore Commoners Association.

#### 3. Police Matters

Three recorded crimes in the area, one each for Public Order, Criminal Damage and Malicious Communication. In addition there were a road traffic accident outside the Watermill Eatery, two antisocial orders, a missing child (subsequently found well) and reports of a suspicious man involving cars.

A number of reports were raised concerning the instances of inconvenient parking in Somerset View, outside the shops in Ogmore and in the vicinity of the Fox in St Brides Major. PC Williamson agreed to monitor the situation. A member of the public also raised instances of excessive speed through St Brides Major. PC Williamson explained that Operation Snap being managed by South Wales Police is an exercise where the public can supply video or photographic evidence to the Police evidencing "where road traffic offences have been committed".

#### 5. Matters Arising

# **5.1 Sports Pavillion:** No update as to the pavilion building.

The pavilion is still in use despite its condition. There is still interest in responsibility for the building being transferred to the Community Council, albeit not in its present state. The Pavillion Working Group to meet with VOG councillors and report back.

**5.2 Annual Report:** The Council's entry of the Annual Report to the One Voice Wales Annual Awards was rewarded with a commendation from the Awards Panel.

- **5.3 Rubbish Bins:** Feedback is still being received from constituents regarding the removal of bins and the negative effect on rubbish and dog excrement pollution. It was agreed that the Community Council would write to the VOGC expressing our concerns.
- **5.4 Bus Shelters:** Cllr Stephens provided a quote following an action from a previous meeting which was discussed. It was agreed that due to the cost implications it was prudent to seek an alternative quote. The Council would then priorities which shelters needed immediate work and plan the work over a number of Budget Years.
